Like natural stone, Caesarstone® quartz surfaces has an equally long-life span, and as a reconstituted quartz maintains consistent quality and strength.

Caesarstone is available in a range of decor's and finished and is intended for use as a benchtop, splashback, countertop and tabletop surface in residential and commercial applications.

Caesarstone is for interior use only (refer to Caesarstone Brochure for Outdoor Collection), it is suitable for horizontal benchtop and countertop applications such as food preparation surfaces and bathroom vanities.

Caesarstone is also suitable for use as a splashback.

Although less common it can also be used as a wet area / shower enclosure wall lining.

Caesarstone is fabricated by suitably qualified and approved stonemasons / fabricators.

Caesarstone Outdoor Collection – there are two (2) decors suitable for outdoor use, Palm Shade and Clearskies.

Conditions of use

Caesarstone is not intended for exterior use

- (other than Caesarstone Outdoor Collection decors)

Caesarstone must be fabricated and installed by a suitably qualified and Laminex New Zealand approved Caesarstone fabricator.
