Product description

Laminam Slim Porcelain Tile (Laminam 3+mm & Laminam 5+mm), is a porcelain tile for use in indoor and outdoor applications, such as cladding, walls, flooring and facade's.

Laminam 3+mm & 5+mm can also be used for splashbacks.

Laminam 3+mm and 5+mm Laminam is made by wet grinding of clayish raw materials, granite and metamorphic, feldspar containing rocks and ceramic pigments. Compacted by a special shaping in compatter and sintering at 1200°C, with hybrid firing with single gauge square edge and with a structural reinforcement inert material (fiberglass blanket bonded at the back).

Laminam 3+mm and 5+mm tile is non-combusitble.

Scope of use

Laminam 3+mm is ideal for wall linings, splashbacks and low impact resisdential flooring

Laminam 5+mm is ideal for wall linings, flooring and splashbacks

Laminam 3+mm and 5+mm is suitable in wet and dry areas, such as bathrooms, open & closed shower enclosures and laundries.

Laminam 3+mm requires a mineral board or 9mm fibre cement substrate when a gass cooktop installation is less than 200mm from the flame.

Laminam 3+mm and 5+mm has an impervious and easy to clean surface for use in hygiene and food preparation areas.

Laminam are fixed using wet cementitious adhesive to a suitable substrate such as fibrecement sheet. It can also be installed using non-properitary metal profile fixing systems.

Conditions of use

Laminam 3+mm and 5+mm require specialist handling, cutting and fabrication tooling and as such is sold only to approved fabricators.

Fabrication and installation must be carried out by a suitably qualified and Laminex approved fabricator and installer.
