Laminex[™] Timber Veneer is:

- not intended for exterior use
- not intended for use in high humidity or wet applications such as saunas or shower/wash down rooms
- not for use where the substrate could come into contact with water. Failure to keep dry will affect the performance of the panel
- not recommended for use in areas with high exposure to natural light
- is not a finished product. It will need to be finished and polished as part of the fabrication process. Advice should be sought from a coating specialist.
- not fire rated as part of a fire protected boundary or fire wall
