Melteca® Standad on MDF E0 & MDF E0 MR is manufactured by laminating sheets of paper impregnated with melamine resin to both sides of Lakepine® Medium Density Fibreboard E0 or Lakepine® Medium Density Fibreboard E0 MR substrate under heat and pressure. The resin on the top surface of the paper cures, forming a tough, stain resistant finish.

Melteca® is available in six different finishes and a range of colours, patterns and woodgrains.

Standard Melteca® on MDF E0 and MDF E0 MR is available in the following thicknesses (dimension in mm):

9, 12, 16, 18, 25 and 30 – refer to Melteca® Availability Guide for sheet sizes and finishes available per decor.
